I have found no issues to note in the reporting of the reviewed 2018 financials

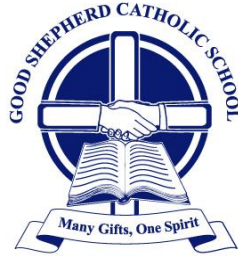
I am pleased to advise that as a result of my review, I am able to issue an unqualified opinion in regard to the financial statements.

**President Annual Report**

The Good Shepherd Parents and Friends Association has had another action-packed year. The 2018 P&F Committee is a diverse group all coming together to cover 3 very important areas: Fundraising; FriendRaising; & School Community; and I do believe we have covered each one to the best of our ability.

We have followed on from our 2017 goals and continued to work towards improving our connection with the whole school community in all of our events.

We have done this through our Facebook page and in conjunction with the school app, both of which have assisted this by giving us maximum exposure and connection to our school community.

The 2018 P&F Committee this year comprised of Rebecca D'Andrea (Vice President), Silvia Scriva (Treasurer), and Nicole Sadler (Secretary). Many thanks go to Kylie Debono for her contribution as Secretary for Semester 1.

In addition, we have a wonderful group of committee members – Nadia Campbell, Jessica Heketa, Genie McGrath, Steve Noble, Sandra Palmer, Tam Puglisi (Facebook coordinator), Rebecca Sharman & Holly Vecchio. Along with a long list of parent helpers that make each and every one of our events a true success. Their contributions have been invaluable and without their commitment we would not have achieved so much.

Fundraising Events for 2018 included our 2<sup>nd</sup> School Camp Out. This was a great community building event. It was wonderful seeing families camping for the first time, seeing all the kids interacting and the Dads bonding around the Campfire. Other fundraising events also include the Mother's & Father's Day stalls; Discos; TKD sausage sizzle and Entertainment Books which are always a winner.

Our biggest fundraiser for the year is our annual Fun-a-thon which raised a staggering \$5,838.20. The kids had a blast with the addition of new obstacles which were made that much more entertaining with the music and our energetic sports teacher Mr B joining in. Along with this, we also had a very successful Bunnings Sausage Sizzle selling over 800 sausage raising a total of \$1,562. This was even supported with a team of teachers who took on a session of cooking.

The Scholastic Book Fair held in August was also very successful and we are hoping that our commission from the total sales will allow us to purchase the 2019 Lit Pro program. A highlight of the book fair for the second year in a row was storytime with the wonderful Mrs Caridi. As always she drew a big crowd again with over 85 children staying after school to hear her awesome stories all while enjoying popcorn & juice.

Our first FriendRaising event for 2018 was kicked off with the annual Sundowner. It was a lovely evening with over 300 people attending. The bouncy castle & the numerous sporting activities available to the children proved to be a hit. It was also wonderful to have Father CJ and several teachers attend and join in on all the fun.

Throughout the year, we continued to embrace and grow with the school community. This includes the ongoing school banking as well as a morning tea provided for Good Shepherd Parish in August. These activities continue to develop our relationship between the school and the community.

Through all of these events we have successfully raised \$11,000 and have been able to contribute \$10,000 to the school through various avenues. These include our new Sustainability Program, the Sensory Programs including new equipment, as well as new Table Tennis sets & 2 fabulous New School Marquees. In addition we are also very proud to be contributing \$25,000 to the Senior Playground.

These events could not have been a success without the generosity and help from our school community; the support from the school administration; and the wonderful bunch of Teachers that we are lucky enough to have at our school.

But most of all I would like to thank the 2018 committee and the long list of volunteers for their dedication and support over the year.

I hope 2019 is just as successful.
